

TERMS AND CONDITIONS OF THE PRIZE DRAW TURISMO ANDALUZ – WTM LONDON 2025

1. ORGANISING ENTITY

The Public Company for the Management of Tourism and Sport in Andalusia (hereinafter referred to as “Turismo Andaluz”), with registered offices at C/ Compañía, 40, 29008 Málaga (Spain), is organising this prize draw (hereinafter, the “Promotion”) for promotional purposes. It is aimed at visitors to the Turismo Andaluz stand at the WTM London 2025 trade fair who register via the stand hosts’ app.

2. START AND END DATES

The Promotion will take place during WTM London 2025, from 4 to 6 November 2025.

The prize draw will be held on Wednesday 12 November 2025, and the winner will be contacted thereafter.

3. ENTRY REQUIREMENTS AND MECHANICS

Participation is open to individuals over the age of 18 representing companies visiting the Andalusia pavilion, who register through the app provided by Turismo Andaluz stand hosts at WTM London 2025. The purpose of the app is to arrange meetings and facilitate networking with Andalusian businesses.

Participants will receive a personalised NFC wristband, enabling them to initiate meetings with Andalusian companies using the tablets available at the designated meeting areas.

A random draw will be conducted from among all registered participants to select the winner.

4. PRIZE CONDITIONS AND DETAILS

A single winner will be selected at random.

The prize includes:

- A 3-night stay in Andalusia for two people in a 4-star hotel, on a bed and breakfast basis.
- Flights to and from Andalusia for two people are included.
- One local experience or visit at the destination.

Prize conditions:

- The trip must be booked at least two months in advance.
- The prize cannot be redeemed during peak season.
- The prize is non-transferable and cannot be exchanged for cash.
- The prize must be used by 3 August 2026.

The winner's name will be published on the website **andaluciacrushlink**, where further details regarding the draw and its outcome will also be made available during the month following the event.

The winner will be contacted using the registration details provided via the app. They will have **7 calendar days** to accept the prize. Should they fail to respond within this period, a runner-up will be contacted.

5. RESTRICTIONS

The following individuals are not eligible to participate:

- Employees of Turismo Andaluz or any companies collaborating in the organisation of the prize draw.
- Anyone directly or indirectly involved in the execution of the draw.
- Representatives of Andalusian companies exhibiting at the event with Turismo Andaluz.
Turismo Andaluz reserves the right to modify the Promotion if duly justified circumstances arise.

6. DISCLAIMER

Turismo Andaluz accepts no responsibility for any issues arising from participation in the prize draw or from use of the prize by the winner.

7. DATA PROTECTION

Personal data provided by participants will be processed in accordance with Regulation (EU) 2016/679 (GDPR) and used solely for the administration of the draw.
